Section A Objectives and activities

Summary of the objects of the charity as set out in its governing document	The objectives of the group is as a unit of the Scout Association. The purpose of scouting Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.	
Summary of the main activities in relation to these objects	The Group main function is to support the sections in achieving the aims of the Scout Association. As a Group the main activities during the last twelve months have been: Significant fundraising Grant Applications Purchasing new equipment to support new programme Equipment servicing and renewal Hut maintenance The Provision of Scouting within the Group is totally dependent on the contribution made by volunteers.	
Public Benefit	The Trustees have paid due regard to the Charity Commission guidance on Public Benefit on deciding what activities the charity should undertake. Membership subscriptions are charged to cover the immediate running costs of the Group and these do not unduly restrict membership. The Group follows the principle that no one should be excluded because of their inability to pay membership subscriptions Two key principles demonstrate scouting's aims are for the public benefit are that through the scout method young people develop towards their full potential and there is a clear link between the benefits for young people and the purpose of scouting. The safety of young people is taken very seriously and the benefits scouting activities provide far outweigh the risks. Any private benefits from scouting are incidental, other than to those as beneficiary.

Summary of the main achievements of the charity during the year	The Executive Committee has maintained fund raising throughout the year. Gift Aid and grant applications have been successful, with hut maintenance still on going. The major project for this year has been the refit of the
	kitchen, which has been completed almost fully by some of our leadership team, with the help of some willing
	explorer scouts. Due to the popularity of the group event at our centenary in 2014, group camp is continuing as an annual event. It is wonderful to see our young members

continuing with scouting and becoming young leaders	
within the group. This is all due to the support and

Policy on Reserves	The Group policy on reserves is to hold sufficient resources to continue the charitable activities of the district should income and fundraising activities fall short. The Group Executive Committee considers that the group should hold a sum equivalent to 12 months running costs, approximately. The Group held free reserves of approximately £6000 against this at year-end
Further financial review details	The Group does not have sufficient funds to invest in longer term investments. The Group has therefore adopted a risk averse strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies
